

NOTIFICATION

In continuation to Commission's Advertisement No.PSC-R(A)/28/2019 Dated 11.02.2020 and subsequent Addendum of even number Dated 3rd July, 2020 and No.PSC-R(A)/28/2019 (Vol-II) Dated 24th Sept,2020, it is to clarify that the actual no. of post of Labour Officer under the Department of Labour & Employment is 1 (one) post instead of 3 posts vide Govt. Letter No.PERS-90/2019 Dated 27th October, 2020. With the exclusion of 2 posts of Labour Officer, the total no. of posts of APPSCCE, 2020 have reduced to 111 from 113 posts.
