Note:

- 1. The engagement shall be purely on temporary contract basis on a fixed remuneration initially for a period of one year and is likely to be curtailed or extended on performance basis or until the project lasts.
- 2. The applicant shall have no right to claim for regularization of his/her services under any circumstances, either in MDNIY or the Hospital where they will be deputed to work
