**NOTIFICATION**

Applications are invited from the eligible candidates up to **5-00p.m** on **21.10.2021** in the format enclosed herewith for appointment to the posts of Court Assistant and Court Attendant to work in the Courts of Special Judicial Magistrate of Second Class of Khammam District Unit.

The applications shall be addressed to the Prl. District and Sessions Judge, Khammam and submit the applications by hand in the office of Prl. District Court, Khammam (or) through post.

The term of the post of Court Assistant and Court Attendant is two (2) years and shall be paid remuneration of Rs.5000/- for Court Assistants and Rs.3000/- for Court Attendants per Month.

**The vacancy position of the posts:**

**I. ELIGIBILITY:**

- Must have passed Intermediate Examination conducted by A.P/ Telangana, State Board of Intermediate Education or its equalent examination for the post of Court Assistant. Must have passed 7<sup>th</sup> class examination for the post of Court Attendant.
- Any retired person who held any post i.e Assistant, Examiner, Typist, Copyist and above in the Judicial Department is eligible for appointment of Court Assistant. Any retired person who held the post of Attender, Process Server or in any post in the last grade service in the Judicial Department is eligible for appointment of Court Attendant.

**II. AGE:**

- As on 01.07.2021 the candidates must not have completed (34) years and must have completed (18) years. The relaxation of maximum age limit is 5 years in respect of SC/ST and BC candidates and 10 years in respect of physically handicapped and Ex-Service Men.
- Any retired employee who crossed the age limit of 65 years shall not be eligible for the appointment of Court Assistant and Court Attendant.


**III. Self attested copies of the documents to be enclosed to the application**

- Certificates of Academic qualification.
- Certificate evidencing date of birth.
- One recent passport size photograph of the applicant is to be affixed at the top of the application in the place specified
- Retired employees are to be produce retirement proceedings.

**IV. GENERAL INSTRUCTIONS:**

- Application to be submitted in the enclosed proforma and applications received in any other format will be summarily rejected.
- In the event of more than 20 candidates applying for each vacancy such applications will be short listed on the basis of marks obtained in the qualifying examination and the candidates who are considered most suitable for appointment will be called

3. No. T.A. will be paid for candidate for journey performed in connection with recruitment.
4. Applications will insufficient information will be summarily rejected.
5. Applications, which do not contain necessary enclosures as detailed above will be rejected.
6. Applications **received after 5.00p.m. on the date prescribed above** will not be considered.
7. The office is not responsible for any postal delay, delay caused by any other service like courier or delay in delivery etc., and no correspondence will be entertain in any respect.
8. Candidate resorting to bring any influence of any kind will be summarily disqualified.
9. The appointing Authority reserves the right to cancel the notification without assigning any reason thereof.
