2. Applications of only such officials/candidates will be considered which are routed through proper channel and are accompanied with (i) Bio Data in the Performa at Annexure-I, (ii) Attested copies of ACRs of the last five years and (iii) Certificate to the effect that they are clear from vigilance/disciplinary angle, integrity certificate and a statement showing major/minor penalties imposed in last 10 years, if any.

3. The last date for submission of applications shall be 20<sup>th</sup> May, 2022. No application received after the due date shall be entertained. Incomplete applications or applications received without ACRs will not be accepted.

Initially, the term of deputation shall be one year from the date of joining, extendable for three years subject to performance of the officer which may be curtailed at any time by the competent authority without assigning any reason or opportunity. The other terms and conditions of the persons appointed on deputation shall be governed by the Haryana State Pollution Control Board Employees Service Regulations, 2021 and the other rules/instructions issued by the Government from time to time.
