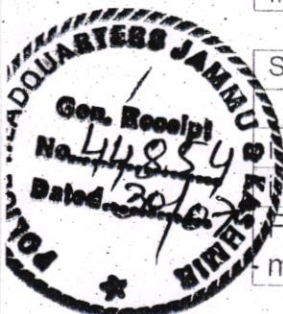

Applications must be submitted as per enclosed proforma along with self-certified copies of following documents and photographs; -




