Those who have undergone DNB training from Institution given under para 2 at (a) & (b) of aforementioned NMC notification will not need to have extra experience after qualifying degree.

Those who have undergone DNB training at Institutions given at (c) & (d) of aforementioned NMC notification will need to have 1 year & 2 years extra experience i.e. total 4 & 5 years' experience respectively from NMC recognized / permitted institutions for equivalence.

## **GENERAL CONDITIONS**

1. All the posts carry usual allowances as admissible to Central Government Employees of similar status at Guwahati, Assam.

2. **Application Process:** The aspiring applicants satisfying the eligibility criteria in all respect can submit their application through **ON-LINE mode followed by submission of hard copy of online application & self-attested copies of supporting documents**. The **last date of online submission of applications will be 30 days from the date of publication of the advertisement** in Employment News/Rojgar Samachar. 4. The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling eligibility criteria as on the closing date of online applications failing which their application will be rejected.

**Professor/Additional Professor:** Not exceeding 58 (Fifty-Eight) years as on the last date of the online application i.e. 30 days from the date of the publication of this advertisement in Employment News/Rojgar Samachar.

**Associate Professor/ Assistant Professor:** Not exceeding 50 (Fifty) years as on the last date of the online application i.e., 30 days from the date of the publication of this advertisement in Employment News/Rojgar Samachar.

i. Upper age limit shall be determined as on last date of submission of online applications.

ii. No age relaxation would be available to SC/ST/OBC/EWS candidates applying for unreserved vacancies.

11. Candidates applying under any of the reserved category posts, viz. SC/ST/OBC/PwBD (OH-OL & BL)/EWS will be considered subject to Caste/PwBD Certificate issued by the appropriate/Competent Authority on the prescribed format. Community should be clearly and legibly mentioned in the Certificate.

12. Applicants applying for the posts reserved for OBC must obtain certificate of OBC (non- creamy layer) in the prescribed form (**Annexure-II & III**) issued by Competent Authority. The certificate should be of the current financial year, in accordance with instructions issued by the Government of India in this respect from time to time.
